The invitation of quotation is subject to the following terms & condition

- 1. The Survey Firm, Company, authorized firm of company & Consortium having expertise in survey works are only eligible to participate & necessary supporting documents to be furnished.
- 2. The bidder should produce valid trade license copy.
- 3. The bidder should furnished copy of GST registration & Last quarter GST return.
- 4. The bidder should be an ISO certified firm or authorized business partner of an ISO certified firm.
- 5. The firm should have at least land survey experience of 1200 SgKm in Arunachal Pradesh.
- 6. The firm should have at least 2 DGPS in proper working condition.
- 7. Company should have minimum numbers of 20 senior Officers in pay role basis.
- 8. The company/consortium should have at least seven years of working experience in Arunachal Pradesh.
- 9. Earnest money @ 1% for the APST & 2% for Non APST firm of the estimated value to be deposited in the form of Demand Draft in favour of Director, Deptt of Geology & Mining, A.P Itanagar which is returnable after completion of tender & selection process.
- 10. The price coated should be inclusive of GST & other taxes.
- 11. 3% of the total value should be deposited as performance guarantee by the successful bidder which shall be refunded after 6 (Six) months on satisfactory performance & submission of all reports as mentioned in the terms & condition.
- 12. Applicable GST/Income Tax shall be deducted from the bill.
- 13. The works to be completed within the specified time and supply of goods within the specified time of 60 (Sixty) days.
- 14. The survey works to be carried out under the strict guidance/supervision of the deptt & in consultation with the respective AMDOs.
- 15. Reports shall be included all baseline information such as local geology, geomorphology, rock lithology, geo-referencing, mineral sampling, structure geology, drainage pattern, climate, flora and fauna, land use pattern, etc.
- 16. All maps, plates, and sections should be in appropriate scale
- 17. No advance payment will be made.
- 18. The payment to be made only on completion of survey & submission of report which will be verified & certified by the deptt Officer.
- 19. The reports or supply of materials in the event of deviation from the specification or fail to complete the works are subject to rejection & entire amount of performance guarantee will be forfeited.
